**GENERAL DESCRIPTION OF WORK:** Individual performs a variety of building trades/janitorial work in the repair, maintenance and construction of Government facilities, including: buildings, utility systems, pavements, grounds and real property installed equipment.

**NATURE AND SCOPE OF WORK:**

Under general supervision, performs a variety of skilled and semi-skilled work at the full-performance level in the mechanical and building trades in connection with the maintenance and repair of Military Authority Assets including buildings, grounds and related mechanical equipment. Work assignments require skill in and knowledge of maintenance and repair methods and practices in several building maintenance trades. Performs related work and other duties as assigned.

**EXAMPLES OF WORK:**

Repairs and replaces walls, floors, steps, doors, window frames, tables, chairs, and other wooden articles or equipment using saws, power and hand tools.

Repairs and replaces lighting fixtures, bulbs, switches, and wiring; installs simple electrical equipment and assists in installation and repair of electrical equipment.

Repairs and replaces sinks, toilets, faucets, pipes, drains, and water lines; unstops toilets, drains and Sewer lines; cleans grease traps.

Performs masonry repair work such as preparing cement, installing reinforcing steel rods, patching and finishing cement work, and replacing damaged masonry.

Paints window frames, tables, chairs, building sheds, rooms, and equipment.

Starts, monitors operational readings, makes necessary adjustments, and shuts down boilers and unfired pressure vessels; tests boiler water and adds chemicals as needed.

Gathers and disposes of trash and waste materials.

Moves furniture, loads and unloads supplies, moves equipment by hand or with dollies and performs other manual tasks.

Perform building service work such as sweeping, mopping and vacuuming floors and washing walls, windows, mirrors and fixtures.

May perform routine ground work such as mowing and trimming, removing snow, sweeping sidewalks, and picking up trash.

**KNOWLEDGE, SKILLS, AND ABILITIES:**

Knowledge of the standard methods, practices, tools and equipment used in a variety of building maintenance trades, HVAC, carpentry and painting trades.

Knowledge of the qualities, adaptability and uses of various woods and materials. Knowledge of the occupational hazards and related safety procedures.

Ability to safely operate tools and equipment used in building maintenance. Ability to perform routine carpentry, plumbing, electrical, and masonry work. Ability to determine materials needed for specific tasks.

Ability to perform physically arduous tasks.

Ability to understand and follow oral and written instructions.

Ability to read and work from blueprints, drawings, sketches or schematic diagrams. Ability to safety work at various heights on ladders, platforms and scaffolds.

**MINIMUM QUALIFICATIONS: TRAINING:**


High School diploma or equivalent.

**EXPERIENCE:**

One year of full-time or equivalent part-time paid experience or paid self-employment in heating, cooling, ventilation, building maintenance, or building trades such as carpentry, plumbing, electrical, plasterer, welder, machinist or masonry or janitorial paid experience.

**SPECIAL REQUIREMENTS:**
